### History of the Transportation Bill

 Background on past transportation bills as compared to proposal by Biden.

## Contents of Biden's Transportation Bill

- \$85 billion Public Transit
- \$80 billion Passenger and Freight Rail Service
- \$25 billion Airports
- \$17 billion Inland Waterways, Coastal Ports, Land Ports of Entry, & Ferries
- \$20 billion Transportation Equity
- \$25 billion Regionally or Nationally Significant Projects
- \$50 billion Infrastructure Resilience

- \$110 billion Drinking Water, Wastewater and Stormwater Systems
- \$100 billion Broadband
- \$100 billion Energy
- \$213 billion Affordable and Sustainable Housing
- \$100 billion Public Schools
- \$12 billion Community Colleges
- \$25 billion Child Care Facilities

# Funding of Bill

- The primary funding mechanism would be to increase the corporate tax rate from the current 21 percent rate to 28 percent.
- The proposal would significantly tighten a number of international tax enforcement provisions created as part of the 2017 Trump tax cuts law (the Tax Cuts and Jobs Act), such as taxes on Global Intangible Low-Taxed Income (GILTI), and a significantly expanded budget for tax enforcement through the Internal Revenue Service (IRS).

#### Project Requests

 Unlike recent Transportation Reauthorization bills, Congressionally directed projects will be allowed in this legislation.

 Exact details and timelines are under consideration; however, the House Transportation and Infrastructure Committee has provided some guidance.

# Project Requirements

In addition to basic project information, the Committee will require all submissions to include the following for a project request:

- Documentation that the project is on the State, Tribal, or territorial transportation improvement program (STIP); and on the metropolitan transportation improvement program (TIP), if applicable
- Sources of funding for the full share of the cost of the project beyond the amount requested
- Letter(s) of support from the State department of transportation, or local government, transit agency, or other non-Federal sponsor
- A description of the process that has been or will be followed to provide an opportunity for public comment on the project
- Project phase (e.g. Planning, Final Design, Construction)
- NEPA category of action (e.g. Categorical Exclusion, Environmental Assessment, Environmental Impact Statement)
- Status of environmental review
- Whether the project has received Federal funding previously, and if so, the source and amount
- Certification that the Member, their spouse, and other immediate family members do not have a financial interest in the project
