#### SCHOOL BUS SAFETY FACTS

- According to the New York State Association of Pupil Transportation (NYAPT):
  - There are more than 50,000 school buses in New York State
  - School buses transport over 2.3 million children to and from school each day
  - An estimated 50,000 motorists pass stopped school buses with red lights flashing each school day
- According to the National Highway Traffic Safety Administration (NHTSA):
  - School buses are the safest vehicle on the road
  - Students are about 70 times more likely to get to school safely when taking a school bus instead of traveling by car

# GOVERNOR'S TRAFFIC SAFETY COMMITTEE

Highway Safety Act of 1966 –

An act to provide a coordinated national highway safety program through financial assistance to the States

■ Goal –

Reduce traffic accidents and deaths, injuries and property damage

#### **GRANT PROGRAMS**

#### Child Passenger Safety


Mini grants — fitting stations, awareness classes, check events, low-income education & distribution programs

#### Highway Safety Grants

Highway safety programs — motorcycle safety, distracted driving awareness, pedestrian/bicycle safety, teen driver safety, older driver safety, school bus safety

#### Police Traffic Services

Traffic safety enforcement — speeding, aggressive driving, distracted driving, seat belts, passing a stopped school bus



#### Operation Safe Stop

- Education and enforcement program to create awareness about the dangers of passing stopped school buses
- This year: Thursday, April 28, 2022

#### NEW YORK STATE SCHOOL BUS SAFETY LAWS

#### **BASIC OVERVIEW**

- Section 1174(a)
- It is illegal to pass a stopped school bus with red lights flashing
- Must stop when:
  - Approaching from the front
  - Overtaking from the rear
  - On public and private roads
  - On divided and multilane highways
  - On school grounds

## **PENALTIES**

By Conviction	Minimum Fine	Maximum Fine	Possible Imprisonment
First Conviction	\$250.00	\$400.00	Up to 30 days
Second Conviction (within 3 years)	\$600.00	\$750.00	Up to 180 days
Third or Subsequent Convictions (within 3 years)	\$750.00	\$1,000.00	Up to 180 days

#### NEW YORK STATE SCHOOL BUS SAFETY LAWS

#### **DEMONSTRATION PROGRAMS**

- Section 1174-a
- School Bus Stop Arm Cameras
  - County, city, town or village-wide
  - Must be in coordination with a school district
  - Cost falls onto county, city, town, or village
  - Monetary penalties of \$250-\$300 for vehicle owner

#### **Statistics**

NYAPT survey's -50,000 illegal passings each school day

Stop arm camera data

Last fatality in New York - 1999 - New Rochelle

28 PM fatalities since 1960

Near misses still happen



### Causes



Hurried pace of our society



Lack of knowledge of the law

#### **Penalties**

- ▶ 1174 violations
  - First offense \$250-\$400 fine and/or 30 days in jail
  - ▶ Repeat offenders up to \$1000 fine and up to 180 days in jail
- ▶ 1174A Violations
  - First offense \$250 fine
  - ► Repeat offenders \$300 fine within 18 months
